Office Strategic Plan and Demographic Data- Statistics of the Native American Tribes: we analyzed Native American data in education, household, unemployed, high school dropout, medium income, age, receiving benefits, retired, vehicles and voting. Through

this data 7 areas of need were established: Workforce development, Disaster Response and Recovery Assistance, Education, Broadband, Economic Development, Healthcare, and Infrastructure, Director Vidrine has submitted our budget, and I am hoping to be able to see this vision become a reality.

MMIWC- Murdered Missing Indigenous Women and Children is a task force that was started last year. This task force will be changed into a commission or an agency for the safety of native women and children. We are proud that our Jordan Butler will continue sitting on this committee.
